## Appropriation No. S-24-223-J Multi-Pronged Approach to Addressing Domestic Violence Award Amount: \$47,623.00

**Justification for the establishment of the account or fund:** To build on the work initiated during previous project periods aimed at ending domestic violence through a sustained multipronged effort that includes educating stakeholders as well as the larger community, providing effective domestic violence intervention programs for those who perpetuate intimate partner violence, and supporting coordinated community responses across the state.

**Source of revenue for the fund:** U.S. Department of Justice, Office on Violence Against Women through the Department of the Attorney General

## Appropriation No. S-24-226-J Electronic Citation Traffic Records (FY 24) Award Amount: \$39,357.00

**Justification for the establishment of the account or fund:** To continue support of the Electronic Citation Pilot Program on Maui with the purchase of electronic citation user licenses and issuance of tracking software and Kofax services.

**Source of revenue for the fund:** National Highway Traffic Safety Administration Fixing America's Surface Transportation Act 402, through the State of Hawaii Department of Transportation

Appropriation No. S-24-227-J Gunshot Detection Program Phase 3 (FY 24) Award Amount: \$202,100.00

**Justification for the establishment of the account or fund:** To mitigate, prevent, prepare, respond, and recover from threats and incidents of terrorism.

**Source of revenue for the fund:** Department of Homeland Security, Federal Emergency Management Agency, through the State of Hawaii Department of Defense
