### Programs

CADR provides alternative dispute resolution (ADR) throughout the state so that disputes may be resolved without the emotional and financial costs of litigation while preserving relationships between parties. Making ADR services available through the Judiciary helps build public confidence in our judicial system and enhances access to justice.

Program Activity FY 2022–2023

• Hawai'i Appellate Mediation Program (AMP) Since AMP's inception in 1995, 802 cases entered the program. The overall settlement rate for closed cases is 49 percent. In FY 2022–23, AMP added 22 new cases to its 16 pending cases. Of the 38 active cases during this period, 26 cases closed with the following results: 10 settled or partially settled; 14 did not settle; and 2 were withdrawn prior to mediation. Twelve cases carried over to the new fiscal year.

Five new volunteer mediators were welcomed to the AMP Volunteer Mediator panel.

The Appellate Mediation Advanced Skills and Professional Development Symposium, created and delivered in partnership with the Mediation Center of the Pacific, was held in June 2023. Participants could elect to earn two CLE credits.

FY 2022-23 was the third consecutive year that the Access to Justice Commission recognized the AMP Mediators for their pro bono contributions. Volunteer mediators contributed more than 400 hours of service to the community and the Intermediate Court of Appeals.

- Family Court, First Judicial Circuit -Assisted with the Volunteer Settlement Master Process
- Workplace Dispute Resolution Program (WDRP) Administered by CADR to provide options for Judiciary employees to resolve workplace matters

CADR delivered a WDRP training in June '23 for Judiciary Supervisors participating in the Judiciary Supervisor Mentorship Program.

CADR develops programs to deliver quality continuing legal education to the legal community. Of the training and outreach events offered in FY 2022-23, three gave participants the opportunity to earn a cumulative five CLE credits.

### **Community Mediation Centers**

CADR administers a purchase of services contract for mediation and related dispute resolution services with Mediation Centers of Hawai'i, Inc. (MCH). MCH serves as an umbrella organization for the five community mediation centers throughout the state.

The centers, located on Hawai'i Island (Hilo and Kona/Waimea), Kaua'i, Maui, and O'ahu are key partners in providing affordable mediation services statewide. The mediation centers handle landlord/ tenant matters, neighbor/neighbor disputes, consumer/merchant issues, workplace related disagreements and domestic cases, among others.

In Fiscal Year 2023, MCH served 15,615 clients and opened 4,369 cases.
