RELATING TO ADOPTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the effect of 2 adoption as provided for under state law impacts the ability for 3 an adopted individual or the individual's natural family to 4 succeed to a homestead lease or application on the department of 5 Hawaiian home lands applicant waiting list. The purpose of this Act is to allow an adopted individual to benefit both by 6 7 relationship through a natural parent and through an adoptive parent while also allowing the adopted individual and member of 8 9 the individual's natural family to continue to have the same familial relationship. This Act does not affect other 10 11 requirements under the Hawaiian Homes Commission Act, 1920, as 12 amended, or administrative rules beyond recognition of relationship between individuals. This Act does not create 13 14 further exception to the complete termination of a natural 15 parent's rights.

16 SECTION 2. Section 578-16, Hawaii Revised Statutes, is 17 amended to read as follows:

1 "§578-16 Effect of adoption. (a) A legally adopted 2 individual shall be considered to be a natural child of the 3 whole blood of the adopting parent or parents as provided in the 4 Uniform Probate Code, relating to the descent of property. 5 The former legal parent or parents of an adopted (b) individual and any other former legal kindred shall not be 6 considered to be related to the individual as provided in the 7 8 Uniform Probate Code except as provided in this section. 9 An adopted individual and the individual's adopting (C) 10 parent or parents shall sustain towards each other the legal 11 relationship of parents and child and shall have all the rights 12 and be subject to all the duties of that relationship, including 13 the rights of inheritance from and through each other and the 14 legal kindred of the adoptive parent or parents, the same as if 15 the individual were the natural child of the adopting parent or 16 parents. Except as provided in subsection (e), all legal duties 17 (d)

18 and rights between the individual and the individual's former 19 legal parent or parents shall cease from the time of the 20 adoption; provided that, if the individual is adopted by a 21 person married to a legal parent of the individual, the full 22 reciprocal rights and duties [which] that theretofore existed

1 between the legal parent and the individual, and the rights of 2 inheritance as between the individual and the legal parent and 3 the legal relatives of the parent, as provided in chapter 560, 4 shall continue, notwithstanding the adoption, subject only to 5 the rights acquired by and the duties imposed upon the adoptive 6 parents by reason of the adoption.

7 (e) Notwithstanding subsections (b) and (d), if an
8 individual is adopted before that individual attains the age of
9 majority and:

10 (1) The individual is adopted by a spouse of a natural11 parent of the individual; or

12 (2) The individual is adopted by a natural grandparent,
13 aunt, uncle, or sibling of the individual or the
14 spouse of a natural grandparent, aunt, uncle, or
15 sibling;

16 then for the purposes of interpretation or construction of a 17 disposition in any will, trust, or other lifetime instrument, 18 whether executed before or after the order of adoption, and for 19 purposes of determining heirs at law, the rights of the adopted 20 individual and the individual's descendants with respect to the 21 individual's natural family shall not be affected by the 22 adoption, and they shall be included in any determination of

heirs or members of any class, unless specifically excluded by
 name or class.

(f) An adopted individual, who by reason of subsection (e)
would be a member of two or more designation or classes pursuant
to a single instrument, both by relationship through a natural
parent and through an adoptive parent, shall be entitled to
benefit by membership in only one of these designations or
classes, which shall be the larger share.

9 (g) An adopted person shall be considered as a child of
10 both the adopted and natural parents for the sole purpose of
11 determining familial relationships, including the identification
12 of successors to lessees and conditions of leases under sections
13 208 and 209 of the Hawaiian Homes Commission Act, 1920, as
14 amended.

15 [-(g)-] (h) For purposes of this section, if a person has 16 been adopted more than once, the term "natural parent" includes 17 an adopting parent by an earlier adoption.

18 [(h)] (i) An individual legally adopted under the laws of 19 any state or territory of the United States or under the laws of 20 any nation shall be accorded the same rights and benefits in all 21 respects as an individual adopted under this chapter."

JUSTIFICATION SHEET

DEPARTMENT: Hawaiian Home Lands

TITLE: A BILL FOR AN ACT RELATING TO ADOPTION.

- PURPOSE: To allow an adopted individual to benefit both by relationship through a natural parent and through an adoptive parent in a disposition or other designation provided for in accordance with the Hawaiian Homes Commission Act, 1920, as amended, or administrative rules while also allowing the adopted individual and individual's natural family to continue to have the same familial relationship.
- MEANS: Amend section 578-16, Hawaii Revised Statutes.
- JUSTIFICATION: The effect of adoption could impact the ability for an adoptive individual to succeed to a homestead lease, to qualify as an applicant on the Department's waiting list, or succeed to an applicant's application on the Department's waiting list. This bill allows an adopted individual to benefit both by relationship through a natural parent and an adoptive parent while also permitting the adopted individual and member of the individual's natural family to continue to have the same familial relationship.

Impact on the public: This bill further protects the interest of beneficiaries of the Hawaiian Homes Commission Act, 1920, as amended, by allowing an adopted individual to benefit both by relationship through a natural parent and through an adoptive parent.

Impact on the department and other agencies: This bill could minimize any amendments that could have a detrimental impact to the general public while addressing the nuances specific to the department. Page 2
