BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 266-19.5, Hawaii Revised Statutes, is amended by amending subsection (d) to read as follows: 2 3 The department of transportation may execute capital "(d) advancement contracts pursuant to subsection (a) with a total 4 5 contract value of [\$2,000,000] \$5,000,000 or less without 6 legislative approval. [If the total value of a capital advancement contract pursuant to subsection (a) is greater than 7 8 \$2,000,000 then the department of transportation shall obtain 9 legislative approval in the form of the adoption of a concurrent resolution affirming the purpose, project, and contract issuance 10 11 prior to executing the capital advancement contract.] The total 12 aggregate value of all capital advancement contracts entered 13 into by the department pursuant to this section shall not exceed 14 [\$5,000,000] \$20,000,000 in any [calendar] fiscal year. The 15 department shall submit a report to the legislature of all 16 executed capital advancement contracts for the previous twelve month period from December 1 to November 30 no later than twenty 17

DEPARTMENT: Transportation

- TITLE: A BILL FOR AN ACT RELATING TO CAPITAL ADVANCEMENT CONTRACTS.
- PURPOSE: To increase the total contract value and total aggregate value of capital advancement contracts entered into by the Department of Transportation for harbor improvements and add reporting requirements for the department.
- MEANS: Amend section 266-19.5(d), Hawaii Revised Statutes (HRS).
- JUSTIFICATION: The Department of Transportation, Harbors Division, requests to amend section 266-19.5, HRS, to increase the contract value from \$2,000,000 to \$5,000,000 and total aggregate value threshold from \$5,000,000 to \$20,000,000 for capital advancement contracts entered into by the department for harbor improvements. An increase in the threshold amounts would allow for appropriate funding levels due to anticipated inflation and escalating costs impacting design and construction material and labor costs for future capital improvements.

<u>Impact on the public:</u> The amendment will expedite and fast-track additional projects and prioritized public improvements to harbor facilities. Harbors Division anticipates private entities will be applying for future federal funding and grant opportunities to help finance improvements. The capital advancement contracting vehicle will help to strengthen public private partnership (P3) applications on federal grants.
