1 "(c) No operator of any pickup truck may operate the 2 vehicle with any passenger [twelve years of age or under] in the 3 bed or load-carrying area of the vehicle, unless one of the 4 following applies: An emergency exists that threatens the life of the 5 (1) passenger being transported in the bed or load-6 7 carrying area of the vehicle; or The vehicle is being operated in parades, caravans, or 8 (2) exhibitions [which] that are officially authorized or 9 10 otherwise permitted by law. Any person who violates this section shall be subject 11 (d) 12 to a fine of \$25 for each violation[, provided that any person who violates subsection (c) shall be subject to a fine of \$50 13 14 for each separate-violation]."
