A BILL FOR AN ACT

RELATING TO LICENSE PLATES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The legislature finds that Hawaii's rainbow				
2	license plate design is nearing the end of its current numbering					
3	pattern and will need to be changed. The legislature further					
4	finds that electric vehicle adoption is growing exponentially,					
5	with many major car manufacturers phasing out gasoline-powered					
6	cars completely by 2035. As a result, Hawaii's temporary					
7	electric vehicle license plate numbering scheme will also soon					
8	need to be changed.					
9	Accordingly, the purpose of this Act is to:					
10	(1)	Replace the electric vehicle special number plate with				
11	:	a new, standard zero-emission vehicle number plate				
12		that will eventually apply to nearly all new vehicles;				
13		and				
14	(2)	Renumbering and extending the run of the current				
15		rainbow design-bearing number plates for gasoline-				
16		powered and hybrid vehicles.

width. <u>The directors of finance of each county through majority</u>
<u>consent may include on any number plate appropriate diacritical</u>
marks.

4 The director of finance of the city and county of Honolulu shall contract annually on behalf of the counties for the 5 purchase of all number plates, tags, or emblems required. The 6 council of each county shall appropriate and cause to be paid 7 8 over to the party with whom the director of finance of the city 9 and county of Honolulu shall contract, or to the director of finance of the city and county of Honolulu as the director may 10 direct, such sum or sums as the director of finance of the city 11 12 and county of Honolulu shall determine to be the county's 13 proportionate share of the expense of such contract and the charges connected therewith. The contract shall be made by the 14 director of finance of the city and county of Honolulu as agent 15 16 of the several counties, and the proportionate liability of each county shall be stated in the contract. Notwithstanding any 17 18 other provision of the law, the contract shall constitute a 19 valid obligation of each county for its proportionate share." 20 SECTION 3. The directors of finance of each county shall issue a new series of number plates for any number plates issued 21

1 pursuant section 249-7, Hawaii Revised Statutes, for affixture 2 to hybrid vehicles pursuant to section 249-9(a)(2)(B), Hawaii 3 Revised Statutes, or gasoline-powered vehicles pursuant to 4 section 249-9(a)(2)(C), Hawaii Revised Statutes. 5 SECTION 4. Statutory material to be repealed is bracketed 6 and stricken. New statutory material is underscored. 7 SECTION 5. This Act shall take effect upon its approval; 8 provided that section 3 of this Act shall take effect on 9 January 1, 2025.
