A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to require public
2	access to travel reports submitted by state employees, officers,
3	and other representatives of the State who travel on official
4	state business.
5	SECTION 2. Chapter 40, Hawaii Revised Statutes, is amended
6	by adding a new section to be appropriately designated and to
7	read as follows:
8	" <u>§40-</u> Travel reports; official state business; public
9	access. (a) Any travel report submitted by a state employee,
10	officer, or other representative of any state department or
11	agency, including the judiciary and university of Hawaii, in
12	connection with out-of-state or intra-state travel for purposes
13	of official state business, shall be made available for public
14	review on the comptroller's website in a searchable format;
15	provided that:
16	(1) Any personally identifiable information shall be
17	redacted from the published report;

1	(2)	Out-of-state or intra-state travel for purposes of law
2		enforcement operations need only identify the date,

12	appropriations contained in Act 164, Regular Session of 2023,
13	and this Act will cause the state general fund expenditure
14	ceiling for fiscal year 2024-2025 to be exceeded by
15	\$ or per cent. This current declaration takes
16	into account general fund appropriations authorized for fiscal
17	year 2024-2025 in Act 164, Regular Session of 2023, and this Act
18	only. The reasons for exceeding the general fund expenditure
