A BILL FOR AN ACT

RELATING TO PRIVACY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that H.C.R. No. 225, 2 H.D. 1, S.D. 1 (2019), convened the twenty-first century privacy 3 law task force, the membership of which consisted of individuals 4 in government and the private sector having an interest or 5 expertise in privacy law in the digital era. The concurrent 6 resolution found that public use of the Internet and related 7 technologies have significantly expanded in recent years and 8 that a lack of meaningful government regulation has resulted in 9 personal privacy being compromised. Accordingly, the 10 legislature requested that the task force examine and make 11 recommendations regarding existing privacy laws and rules to 12 protect the privacy interests of the people of the State. 13 The legislature further finds that, following significant 14 inquiry and discussion, the task force recommended that the outdated definition of "personal information" in chapter 487N, 15 16 Hawaii Revised Statutes, which requires the public to be 17 notified of data breaches, should be updated and expanded. 2	and, when exposed to the public in a data breach, can place an
3	individual at risk of identity theft or may compromise the
