# A BILL FOR AN ACT

RELATING TO WATER INFRASTRUCTURE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State does not 2 own or possess complete control of all water infrastructure that currently exists in Hawaii. Often wells, canals, and irrigation 3 4 projects are located on private, county, and federal land, and 5 limited access to these locations may impede the process of 6 categorization. Since management of these resources is a 7 responsibility of the associated agencies affiliated with local 8 and state governments, there is a pressing need to ensure that 9 an adequate inventory of these resources is maintained that may 10 be dedicated to the agricultural industry. The legislature 11 believes that these water projects are of critical importance to 12 overall food production within the State and must be accurately 13 categorized, properly maintained, and effectively managed.

14 The legislature also finds that the regulation and 15 monitoring of wells, irrigation ditches, reservoirs, and pump 16 stations related to farming and agriculture in the State are 17 typically overseen by several agencies having overlapping

priorities and objectives. The department of land and natural 1 2 resources and the commission on water resource management both 3 fulfill significant roles in this complex process. However, it 4 must be noted that statistical data is also gathered by the 5 department of agriculture and the agribusiness development 6 corporation. These agencies provide several informational 7 inputs into a disjointed monitoring system that relies upon 8 cooperation between the differing but complementary agencies. 9 As a result, the State lacks a complete inventory and 10 comprehensive data system to track the condition and maintenance 11 needs of water infrastructure in Hawaii.

Accordingly, the purpose of this Act is to direct the department of agriculture to conduct a water infrastructure study for the State of Hawaii.

15 SECTION 2. (a) The department of agriculture, in
16 collaboration with the agribusiness development corporation and
17 the counties, shall conduct a water infrastructure study for the
18 State of Hawaii.

19 (b) As part of the study, the department of agriculture
20 shall develop an inventory of wells, irrigation ditches,
21 reservoirs, and pumping stations in the State of Hawaii,

including an assessment of the infrastructure's current
 condition and maintenance needs and recommendations for future
 investments in infrastructure.

4 The department of agriculture shall also develop a tracking5 system to report future infrastructure needs.

6 (c) No later than twenty days prior to the convening of
7 the regular session of 2025, the department of agriculture shall
8 submit a report to the legislature of its findings and
9 recommendations, including any proposed legislation.

10 SECTION 3. In accordance with section 9 of article VII, of 11 the Constitution of the State of Hawaii and sections 37-91 and 12 37-93, Hawaii Revised Statutes, the legislature has determined 13 that the appropriation contained in this Act will cause the 14 state general fund expenditure ceiling for fiscal year 2024-2025 15 to be exceeded by \$ per cent. The reasons , or 16 for exceeding the general fund expenditure ceiling are that the 17 appropriation made in this Act is necessary to serve the public 18 interest and to meet the need provided for by this Act.

19 SECTION 4. There is appropriated out of the general
20 revenues of the State of Hawaii the sum of \$ or so much

thereof as may be necessary for fiscal year 2024-2025 for a
 statewide water infrastructure study.

3 The sum appropriated shall be expended by the department of4 agriculture for the purposes of this Act.

5 SECTION 5. This Act shall take effect on July 1, 2050.
