### A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the right to education is fundamental to the success of Hawaii's children and 2 3 youth. On March 7, 1974, the board of education adopted the student bill of rights and responsibilities, which outlines the 4 rights and responsibilities of students as analogous to those of 5 an adult citizen. A copy of this document is distributed 6 7 annually to staff and kept in every school office. 8 The legislature further finds that Hawaii is a place of 9 diverse cultures, practices, races, and ethnicities. It is 10 vital for student success in Hawaii's public schools that historically and culturally accurate educational materials are 11 12 available and that individuals of diverse backgrounds and 13 characteristics are recognized and welcomed. 14 The purpose of this Act is to:

15 (1) Require the department of education to ensure that
16 accurate and inclusive curricula is available to all

4	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
5	amended by adding a new section to part II to be appropriately
6	designated and to read as follows:
7	" <u>\$302A-</u> Inclusive curricula; availability;
8	discriminatory practice; complaints. (a) Beginning with the
9	2025-2026 school year, the department shall ensure that accurate
10	and inclusive curricula are available to all students at public
11	schools in accordance with age guidelines.
12	(b) It shall be a discriminatory practice to refuse to
13	approve, remove, or prohibit the use or access of any curricular
14	materials from a school or public library on the basis that the
15	materials:
16	(1) Address topics related to race; color; ancestry; sex,
17	including gender identity, gender expression, or
18	sexual orientation; religion; or disability; or
19	(2) Are written by individuals who are lesbian, gay,
20	bisexual, transgender, queer, or are questioning their

8	complaint with the civil rights commission in accordance with	
9	the procedure established under chapter 368.	
10	(e) Nothing in this section shall be interpreted to	
11	prevent the department from implementing or using existing age-	_
12	appropriate guidelines in effectuating this section.	
13	(f) For the purposes of this section, "inclusive	
14	curricula" means curricular materials that accurately portray	
15	the cultural and racial diversity of society. "Inclusive	
16	curricula" includes books and educational materials that:	
17	(1) Recognize the contributions of people_of all_genders	
18	in all types of roles, including professional,	
19	vocational, and executive roles;
