A BILL FOR AN ACT

RELATING TO LANDOWNERS OF NUMEROUS ACRES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that there is a need to
 create a dedicated source of funding to fight wildfires that
 occur in large rural areas on privately owned acreage such as
 ranches, farms, and undeveloped land.

5 The legislature further finds that other states have 6 initiated large landowner funds to create dedicated sources of 7 funding to respond to fires that occur in these and surrounding 8 areas. Large landowners have embraced this approach since it 9 helps to ensure that funding and resources are available to 10 minimize loss from wildfires that may occur on their lands.

Accordingly, the purpose of this Act is to assess an annual fee on large landowners and use the revenue from those fees for firefighting and fire prevention.

SECTION 2. Chapter 209, Hawaii Revised Statutes, is amended by adding two new sections to be appropriately designated and to read as follows:
