A BILL FOR AN ACT

RELATING TO WORKFORCE DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii stands as the 2 most isolated population center globally, situated approximately 3 two thousand four hundred miles from the closest landmass, the 4 mainland United States. Given this geographical isolation, 5 efficient transportation is critical for the survival of the 6 State's population and its tourism industry. Commercial drivers 7 license (CDL) holders play a pivotal role in moving shipments 8 from docks and airports to shelves, as storage space is limited 9 within the State.

10 The legislature further finds that Hawaii grapples with a 11 shortage of CDL drivers, a challenge mirrored on the continental 12 United States. The nationwide deficit of truck drivers is 13 reaching alarming proportions, with an immediate need for over 14 eighty thousand truck drivers. If current trends persist, the 15 shortage is projected to double to one hundred sixty thousand by 16 2030, as warned by Haley Fenton of Western Pacific Truck School.

1 The legislature also finds that this scarcity in the number 2 of CDL drivers directly impacts the State's education system, 3 where over two hundred additional CDL drivers are required to 4 fully cover school bus routes statewide, causing some students 5 to ride public transit. To address this growing crisis, it is imperative to develop and implement a strategic plan that 6 7 encourages employment in the CDL license field to ensure the 8 State's economic and social well-being.

9 Accordingly, the purpose of this Act is to create a working
10 group within the department of transportation to address the
11 State's current and future needs for CDL drivers.

SECTION 2. (a) There is established a working group within the department of transportation. The working group shall:

15 (1) Engage both public and private sectors with the goal
16 of increasing awareness of the ground transportation
17 industry and its' workforce needs; and

18 (2) Interface with key stakeholders to create and develop
19 possible career paths for qualified CDL drivers,
