A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that on February 15, 2 2023, at 6:45 a.m., sixteen-year-old Sara Yara was crossing Kapiolani Boulevard in a marked crosswalk by McKinley High 3 4 School when she was struck and killed in a motor vehicle The alleged driver was not the registered owner of collision. 5 6 the motor vehicle, did not have a valid drivers' license, had 7 been convicted of the offense of driving without a license six times during the five-year period before the collision, and had 8 9 one hundred sixty-four prior traffic citations.

The legislature further finds that repeat violations of 10 driving without a license reflect a lack of concern of the 11 dangerousness of the act. The legislature also finds that 12 selling a vehicle to an unlicensed driver or allowing an 13 unlicensed driver to drive one's vehicle creates a situation of 14 potential danger to the community. The legislature believes 15 16 that the severity of the law should reflect these dangers and serve to prevent tragedies like the untimely death of Sara Yara. 17

Prohibits the registered owner of a motor vehicle from allowing an individual who is not duly licensed to operate that category of motor vehicle to operate the vehicle. Imposes penalties.
