### A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the chapters of the 2 Hawaii Revised Statutes relating to mental health and 3 involuntary transport, examination, hospitalization, and 4 treatment have been amended in a piecemeal manner over the past 5 several decades. This has led to some lack in clarity and 6 inconsistencies. It is imperative that such an important part 7 of state law receives full and deliberate attention from time to 8 time to ensure the law's continued force and effectiveness.

9 The legislature further finds that a comprehensive review 10 of the Hawaii Penal Code has been conducted every decade since 11 the Code's enactment in 1972. The legislature believes that 12 periodically reviewing Hawaii's mental health laws would also be 13 helpful to advance the overall goal of improving mental health 14 in the State, especially for those unable to help themselves. 15 The purpose of this Act is to require the department of 16 health to convene an advisory committee on mental health code 17 review every ten years.
