A BILL FOR AN ACT

RELATING TO FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 164, Session Laws of Hawaii 2023, is 2 amended by adding to part VIII three new sections to read as 3 follows: 4 "SECTION 22A. Any provision of this Act to the contrary 5 notwithstanding, the governor is authorized to transfer savings 6 or unrequired balances as may be available from the appropriated 7 funds of any program in this Act to supplement the appropriation 8 for any other program in this Act to cope with the effects of 9 natural disasters or other unforeseen emergencies; provided that the effects of the natural disasters or emergencies create an 10 11 urgent need to pursue a course of action that is in the best 12 interest of the State; provided further that the use of such 13 funds does not conflict with general law; provided further that 14 no funds shall be expended without a formal declaration of a 15 natural disaster or emergency by the governor; provided further 16 that this authority shall not extend beyond July 1 of the immediately succeeding fiscal year; provided further that any 17 18 funds unencumbered or unexpended as of July 1 of the immediately

1	succeeding fiscal year shall lapse as of that date; and provided
2	further that the governor shall notify the legislature within
3	five days of each use of this authority and submit a report to
4	the legislature of all uses of this authority for the previous
5	fiscal year no later than September 1 of each year.
6	SECTION 22B. Unless otherwise provided in this Act, the
7	governor is authorized to transfer operating funds between
8	appropriations within the same fund, within an expending agency,
9	for operating purposes; provided that the governor shall submit
10	a report to the legislature within five days of each use of this
11	authority; provided further that the report shall include the
12	date of transfer, the amount of the transfer, the program ID
13	from which funds were transferred, the program ID to which funds
14	were transferred, the impact to the program ID funds are
15	transferred from, and a detailed explanation of the public
16	purposes served by the transfer of resources; and provided
17	further that the governor shall submit to the legislature a
18	summary report containing the aforementioned information for
19	each use of this authority for the previous twelve-month period
20	from December 1 to November 30 no later than thirty days prior
21	to the convening of the regular session of 2025.

1	SECTION 22C. Notwithstanding any provision in part III of
2	this Act, the governor is authorized to transfer savings or
3	unrequired balances as may be available of general funds from

6	these funds shall be used to prevent, control, and extinguish
7	wildland fires within forest reserves, public hunting areas,
8	wildlife and plant sanctuaries, and natural area reserves, and

JUSTIFICATION SHEET

DEPARTMENT: Budget and Finance

TITLE: A BILL FOR AN ACT RELATING TO FUNDS.

- PURPOSE: To reinstate the Governor's authority to transfer funds for operating purposes, in the case of natural disaster, or to supplement the Department of Land and Natural Resources' Firefighter's Contingency Fund.
- MEANS: Add three new sections to part VIII of Act 164, Session Laws of Hawaii (SLH) 2023.
- JUSTIFICATION: Act 164, SLH 2023, did not contain boilerplate provisions that are generally included in the General Appropriations Act that provide the Governor with authority to transfer funds for operating purposes, natural disaster, or the Firefighter's Contingency Fund. This bill reinstates three provisions that were removed from Act 88, SLH 2021, as amended by Act 248, SLH 2022, and not included in Act 164, SLH 2023.

<u>Impact on the public:</u> This bill enables the Governor the flexibility to transfer funds for natural disaster, operating purposes, or the Firefighter's Contingency Fund. This authority will allow the Governor to better serve the State and the public interest.

Impact on the department and other agencies: This bill will benefit the departments that require transfers to meet operating shortfalls.
