A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR CHARTER SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for
immediate passage in accordance with section 9 of article VII of
the Constitution of the State of Hawaii.

4 SECTION 2. The legislature finds that the department of education is required to provide proportional funding to charter 5 schools based on their student enrollment. While the overall 6 7 enrollment for the department of education has gone up for the 2023-2024 school year, the growth rate for public charter 8 schools has grown even faster at four per cent higher than 9 10 projected. One factor that explains the sudden increased public 11 charter school enrollment is the growing need for temporary 12 school options in Lahaina as a result of the destruction 13 incurred by the devastating August 2023 wildfires. As a result 14 of the increased charter school enrollment, the amount of 15 funding for charter schools is less than what is required.

1 Therefore, the purpose of this Act is to make an emergency appropriation to the department of education to cover its 2 funding requirements for charter schools. 3 In accordance with section 9 of article VII of SECTION 3. 4 the Hawaii State Constitution and sections 37-91 and 37-93, 5 Hawaii Revised Statutes, the legislature has determined that the 6 general fund expenditure ceiling for fiscal year 2023-2024 has 7 already been exceeded by \$ per cent. The 8 or 9 appropriations contained in this Act will cause the state general fund expenditure ceiling for fiscal year 2023-2024 to be 10 11 further exceeded by \$ per cent. This or declaration takes into account the additional general fund 12 appropriation authorized for fiscal year 2023-2024 in this Act 13 only. The reasons for exceeding the general fund expenditure 14 15 ceiling are that: 16 The appropriations made in this Act are necessary to (1)17 serve the public interest; and 18 (2) The appropriations made in this Act meet the needs 19 addressed by this Act. 20 SECTION 4. There is appropriated out of the general 21 revenues of the State of Hawaii the sum of \$6,600,000 or so much

thereof as may be necessary for fiscal year 2023-2024 for the
department of education to provide funding for charter schools.
The sum appropriated shall be expended by the department of
education for the purposes of this Act.
SECTION 5. This Act shall take effect upon its approval.
