
A BILL FOR AN ACT

RELATING TO THE PRESCHOOL OPEN DOORS PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the preschool open
2 doors program serves certain three- and four-year old children
3 with priority extended to certain categories of children. There
4 is currently no priority application period established for each
5 program year. A priority application period would ensure that
6 the preschool open doors program maximizes the funding
7 appropriated to the program to serve the greatest number of
8 three- and four-year-old children in a more timely fashion.

9 Accordingly, the purpose of this Act is to explicitly
10 establish that the priority of selection for the preschool open
11 doors program participation shall apply only to the priority
12 application period between February 1 and the start of each
13 program year, with the program year being the same as the state
14 fiscal year.

15 SECTION 2. Section 346-181, Hawaii Revised Statutes, is
16 amended by amending subsection (b) to read as follows:



1 "(b) Subject to the availability of funds, the program
2 shall serve three- and four-year-old children who are in the two
3 years prior to kindergarten entry pursuant to section 302A-411,
4 with priority extended in the following order [~~to~~] during a
5 priority application period established for each upcoming
6 program year:

- 7 (1) Children who are not eligible to attend public school
8 kindergarten in the calendar year in which they turn
9 five years of age because their birth date occurs
10 after the kindergarten eligibility date pursuant to
11 section 302A-411;
- 12 (2) Underserved or at-risk four-year-old children who were
13 previously served as a three-year-old child, as defined
14 by rules adopted by the department;
- 15 (3) Four-year-old children who were previously served as a
16 three-year-old child;
- 17 (4) Four-year-old children;
- 18 (5) Underserved or at-risk three-year-old children, as
19 defined by rules adopted by the department; and
- 20 (6) Three-year-old children[~~er~~];

1 provided that applications received after the end of the
2 priority application period and through January 31 of each year
3 shall be processed on a first-come, first-served basis for the
4 remainder of that program year. For purposes of this section,
5 "program year" means the state fiscal year."

6 SECTION 3. Statutory material to be repealed is bracketed
7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect upon its approval.

Description:

Establishes that the priority of selection for program participation shall be applicable through the priority application period that occurs prior to the start of each program year. Establishes that applications received after the start of the program year through January 31 shall be processed continuously through the program year on a first-come, first-served basis. (SD1)
