A BILL FOR AN ACT

RELATING TO THE PRESCHOOL OPEN DOORS PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the preschool open 2 doors program serves certain three- and four-year old children 3 with priority extended to certain categories of children. There is currently no priority application period established for each 4 5 state fiscal year. A priority application period would ensure 6 that the preschool open doors program maximizes the funding 7 appropriated to the program to serve the greatest number of 8 three- and four-year-old children in a more timely fashion.

9 Accordingly, the purpose of this Act is to explicitly 10 establish that the priority of selection for the preschool open 11 doors program participation shall apply only to the priority 12 application period between February 1 and the start of each 13 state fiscal year.

SECTION 2. Section 346-181, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: "(b) Subject to the availability of funds, the program shall serve three- and four-year-old children who are in the two

1 years prior to kindergarten entry pursuant to section 302A-411, 2 with priority extended in the following order [to:] during a 3 priority application period established for each upcoming state 4 fiscal year: 5 Children who are not eligible to attend public school (1) 6 kindergarten in the calendar year in which they turn 7 five years of age because their birth date occurs 8 after the kindergarten eligibility date pursuant to 9 section 302A-411; 10 Underserved or at-risk four-year-old children who were (2) 11 previously served as [a] three-year-old [child, -as 12 defined by rules adopted by the department;] children; 13 Four-year-old children who were previously served as (3) 14 [a] three-year-old [child;] children; 15 (4) Four-year-old children; 16 Underserved or at-risk three-year-old children[, as (5) 17 defined by rules adopted by the department]; and 18 (6) Three-year-old children [-;]; 19 provided that:
