SECTION 5. The purpose of this part is to authorize the department of health to implement behavioral health crisis centers to provide intervention and stabilization services for persons experiencing a mental illness or substance use disorder crisis, including a dedicated first responder drop-off area for potential clients.

JUSTIFICATION SHEET

DEPARTMENT: Health

TITLE: A BILL FOR AN ACT RELATING TO MENTAL HEALTH.

- PURPOSE: To expand the scope of criminal justice diversion programs to certain petty misdemeanants, support the expansion of post-booking criminal justice diversion, and authorize the Department to establish behavioral health crisis centers.
- MEANS: Add a new section to chapter 704, Hawaii Revised Statutes (HRS), amend section 704-421, HRS, and add a new section to part I of chapter 334, HRS.
- JUSTIFICATION: Diversion programs provide opportunities for individuals to link with appropriate treatment supports. By establishing behavioral health crisis centers, this bill enhances the diversion program authorized by Act 26, Session Laws of Hawaii 2020, by providing more treatment and service options for the courts and law enforcement to use to fill a gap in the current health care continuum for both prevention and postarrest stabilization.

Impact on the public: This bill will improve public safety in general, improve personal safety and wellness for persons with mental illness, and lead to more efficient use of public resources.

Impact on the department and other agencies: Behavioral health crisis centers will provide additional resources and enhanced authority for the Judiciary, Office of the Public Defender, and county law enforcement agencies.
