## A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is an ongoing 2 need for teachers, counselors, and administrators on the 3 neighbor islands. This critical need is further exacerbated by 4 professionals retiring, leaving the educational workforce, or 5 relocating to live elsewhere. The legislature further finds that Act 141, Session Laws of Hawaii 2022 (Act 141), required 6 the university of Hawaii to establish K-12 expanded teaching 7 cohort programs in each county for students who are pursuing 8 undergraduate degrees in education. However, no funding for 9 this mandate was provided to ensure greater accessibility for 10 program pathways. Act 141 further required the university of 11 Hawaii to submit an interim report to the legislature regarding 12 13 the number of faculty needed and associated costs to establish and administer additional programs in teaching before the 14 convening of the Regular Session of 2024. 15

Accordingly, to fully implement the mandates of Act 141,the legislature further finds that personnel is needed to

1 provide oversight and administrative support for the programs on 2 each island, conduct field supervision, teach courses, recruit 3 and advise candidates, and to serve as the point of contact 4 between the college of education at the university of Hawaii at 5 Manoa and the neighbor islands. 6 Therefore, the purpose of this Act is to appropriate funds 7 to establish: (1) Seven full-time equivalent (7.0 FTE) positions within 8 9 the university of Hawaii at Manoa college of 10 education; and 11 (2) Additional programs in teaching for the university of 12 Hawaii to fully implement the requirements of Act 141. 13 SECTION 2. In accordance with section 9 of article VII of 14 the Hawaii State Constitution and sections 37-91 and 37-93, 15 Hawaii Revised Statutes, the legislature has determined that the 16 appropriations contained in Act 164, Regular Session of 2023, 17 and this Act will cause the state general fund expenditure 18 ceiling for fiscal year 2024-2025 to be exceeded by 19 Ś per cent. This current declaration takes or 20 into account general fund appropriations authorized for fiscal 21 year 2024-2025 in Act 164, Regular Session of 2023, and this Act

only. The reasons for exceeding the general fund expenditure 1 2 ceiling are that: The appropriation made in this Act is necessary to 3 (1) 4 serve the public interest; and 5 (2) The appropriation made in this Act meets the needs addressed by this Act. 6 7 SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$625,000 or so much 8 9 thereof as may be necessary for fiscal year 2024-2025 for: The establishment of seven full-time equivalent (7.0 10 (1) 11 FTE) positions at the university of Hawaii at Manoa 12 college of education; and Additional program costs to fulfill the requirements 13 (2) mandated by Act 141, Session Laws of Hawaii 2022. 14 The sum appropriated shall be expended by the university of 15 16 Hawaii for the purposes of this Act. 17

SECTION 4. This Act shall take effect on July 1, 2055.
