### A BILL FOR AN ACT

RELATING TO CARE HOMES.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Adult residential care homes are facilities 2 providing twenty-four hour living accommodations for a fee to adults unrelated to the family, who require at least minimal 3 4 assistance in the activities of daily living, personal care 5 services, protection, and health care services, but do not need 6 the professional health services of an intermediate, skilled 7 nursing, or acute care facility. Adult residential care homes 8 are a key component in Hawaii's long-term care system providing 9 care to impoverished elderly and disabled residents who cannot 10 rely on anyone else to take care of them. This twenty-four hour 11 supervision serves preventative care needs and keeps the 12 residents' health conditions from developing into crises that 13 require acute care, emergency room usage, or hospitalization. 14 Studies by the American Association of Retired Persons show 15 that Hawaii needs to improve efforts to provide lower cost long-

term care services to the community under Hawaii's med-QUEST

medicaid program rather than the more expensive care in nursing
 homes.

3 Despite their essential services to the community, adult 4 residential care homes have received no rate increase for 5 medicaid recipients for fifteen years. In 2022, the senate adopted S.R. No. 4, S.D. 1 (2022) which requested the department 6 7 of human services to study the feasibility of increasing the 8 medicaid reimbursement rates of adult residential care homes. 9 The study suggested higher rates at all levels were appropriate. 10 Equally essential, adult day programs, including adult day care centers and adult day health centers, enable seniors to age 11 12 in place, socialize, and enjoy planned activities in a group 13 setting, while still receiving needed care and health services. At the same time, adult day programs offer family caregivers 14 15 respite from caregiving duties while knowing that their loved 16 one is in a safe place.

17 Accordingly, the purpose of this Act is to:

18 (1) Increase the medicaid reimbursement rates of adult
19 residential care homes, licensed developmental
20 disabilities domiciliary homes, community care foster
21 family homes, certified adult foster homes, and adult

1 day programs, including adult day care centers and 2 adult day health centers; and Make appropriations to fund expanded-adult residential 3 (2) care homes, community care foster family homes, and 4 5 adult day programs, including adult day care centers 6 and adult day health centers, 7 to improve efforts of providing lower cost long-term and day care services statewide. 8 9 SECTION 2. Section 346-53, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows: 10 11 The director, pursuant to chapter 91, shall determine "(C) the rate of payment for domiciliary care, including care 12 13 provided in licensed developmental disabilities domiciliary 14 homes, community care foster family homes, and certified adult 15 foster homes, to be provided to recipients who are eligible for 16 federal [supplementary] supplemental security income or public 17 assistance, or both. The director shall provide for level of 18 care payment as follows: Beginning on July 1, [2008,] 2024, for adult 19 (1) 20 residential care homes classified as facility type I, 21 licensed developmental disabilities domiciliary homes

18 The department shall handle abusive practices under this19 section in accordance with chapter 91.

20 Nothing in this subsection shall allow the director to
21 remove a recipient from an adult residential care home or other

1 similar institution if the recipient does not desire to be
2 removed and the operator is agreeable to the recipient
3 remaining, except where the recipient requires a higher level of
4 care than provided or where the recipient no longer requires any
5 domiciliary care."

6 SECTION 3. In accordance with section 9 of article VII of 7 the Hawaii State Constitution and sections 37-91 and 37-93, 8 Hawaii Revised Statutes, the legislature has determined that the 9 appropriations contained in Act 164, Regular Session of 2023, 10 and this Act will cause the state general fund expenditure 11 ceiling for fiscal year 2024-2025 to be exceeded by

12 \$ or per cent. This current declaration takes 13 into account general fund appropriations authorized for fiscal 14 year 2024-2025 in Act 164, Regular Session of 2023, and this Act 15 only. The reasons for exceeding the general fund expenditure 16 ceiling are that:

- 17 (1) The appropriation made in this Act is necessary to18 serve the public interest; and
- 19 (2) The appropriation made in this Act meets the needs20 addressed by this Act.

1 SECTION 4. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$5,590,000 or so much 3 thereof as may be necessary for fiscal year 2024-2025 for the 4 funding of expanded adult residential care homes and community 5 care foster family homes. 6 The sum appropriated shall be expended by the department of 7 human services for the purposes of this Act. 8 SECTION 5. There is appropriated out of the general 9 revenues of the State of Hawaii the sum of \$170,000 or so much 10 thereof as may be necessary for fiscal year 2024-2025 for the 11 funding of adult day programs, including adult day care centers 12 and adult care health centers. 13 The sum appropriated shall be expended by the department of 14 human services for the purposes of this Act. 15 SECTION 6. Statutory material to be repealed is bracketed 16 and stricken. New statutory material is underscored. 17 SECTION 7. This Act shall take effect on July 1, 2024. 18 INTRODUCED BY:

Adult Residential Care Homes; Department of Human Services; Medicaid; Med-QUEST; State Supplemental Payments; Adult Foster Homes; Adult Day Programs; Adult Day Care Centers; Adult Day Health Centers; Expenditure Ceiling; Appropriations

#### Description:

Beginning on 7/1/2024, requires that the state supplemental payment for type 1 adult residential care homes, licensed developmental disabilities domiciliary homes, community care foster family homes, and certified adult foster homes not exceed \$767. Beginning on 7/1/2024, requires the state supplemental payment for type II adult residential care homes not exceed \$875. Beginning on 7/1/2024, requires that the state supplemental payment for adult day care centers and adult day health centers not exceed \$63.06 and \$87.21 per diem, respectively. Declares that the general fund expenditure ceiling is exceeded. Makes appropriations.
