A BILL FOR AN ACT

RELATING TO AMERICAN SIGN LANGUAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that American Sign 2 Language (ASL) interpreters provide a critical service to deaf, 3 hard of hearing, deaf-blind, and hearing individuals, and public 4 agencies in the State, who wish to effectively communicate with 5 each other in a variety of settings and circumstances. Despite 6 the increase in requests for ASL interpreting services, there 7 has been increased difficulty in the recruitment of individuals 8 who are qualified to serve as ASL interpreters.

9 The legislature further finds that there remains a critical 10 need to develop an ASL interpreter workforce and additional 11 information on the current condition of ASL in Hawaii would help 12 provide a firm foundation to address other current and future 13 issues relating to this critical service.

Accordingly, to ensure greater access for individuals to receive ASL interpretation services in the state during emergencies and daily life activities, the purpose of this Act is to require the disability and communication access board and

19		as co-chairperson of the working group;

21	(4)	A member of the deaf and blind taskforce;

1	(5)	A professor from the university of Hawaii who teaches
2		American Sign Language;
3	(6)	An individual who currently serves as an American Sign
4		Language interpreter, who shall be invited by the co-
5		chairpersons of the working group; and
6	(7)	Additional representatives invited by the co-
7		chairpersons of the working group.
8	(c)	The working group, with the assistance of the
9	department of health, shall submit a report of its findings and	
10	recommendations, including any proposed legislation, to the	
11	legislature no later than December 31, 2024.	
12	(d)	The working group shall be dissolved on June 30, 2025.
13	(e)	The members of the working group shall serve without
14	compensat	ion, but shall be reimbursed for reasonable expenses
15	incurred,	including travel expenses. No member of the working
16	group sha	ll be made subject to chapter 84, Hawaii Revised
17	Statues,	solely because of that member's participation as a
18	member of	the working group.
19	SECT	ION 3. This Act shall take effect upon its approval.
