A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that according to the 2 American Automobile Association, the average price per gallon 3 for regular gasoline in Hawaii increased from \$4.334 in December 4 2021 to \$5.030 in December 2022. The legislature also finds 5 that motor vehicle manufacturers have begun charging 6 subscription fees for consumers to use certain features in their 7 vehicles, including remote locking, remote ignition, and automatic high-beam headlights. The legislature recognizes that 8 9 these and various other factors are contributing to the increase in transportation costs for residents. The legislature notes 10 11 that it is the State's desire to lower these transportation 12 costs in the State.

Accordingly, the purpose of this Act is to prohibit motor vehicle manufacturers from charging subscription fees for the use of certain services that employ equipment already installed in a motor vehicle at the time of sale.
