
A BILL FOR AN ACT

RELATING TO THE HAWAII FARM TO FOOD BANK PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to establish the
2 Hawaii farm to food bank program and provide a source of funding
3 for the program to provide moneys to food banks in the State to
4 purchase, store, and transport food grown or produced in Hawaii,
5 for distribution to local communities. This program will serve
6 the State's food needs, provide local food producers with a
7 market to support their operations, and keep moneys circulating
8 within the State to boost the local economy.

9 SECTION 2. Chapter 371K, Hawaii Revised Statutes, is
10 amended by adding a new part to be appropriately designated and
11 to read as follows:

12 **"PART . HAWAII FARM TO FOOD BANK PROGRAM**

13 **§371K-A Hawaii farm to food bank program.** (a) There is
14 established the Hawaii farm to food bank program to be
15 administered by the office of community services within the
16 department of labor and industrial relations. The purpose of
17 the program shall be to relieve food shortages experienced by



1 residents of the State, including low-income and unemployed
2 families and individuals, by providing financial support for the
3 distribution of fresh locally grown or produced food to those
4 persons.

5 (b) The office of community services shall make moneys
6 available to food banks located in the State pursuant to
7 subsection (a) using moneys in the Hawaii food assistance
8 program special fund established pursuant to section 371K-B.

9 (c) Food banks that receive moneys pursuant to this
10 section shall use the moneys to purchase, store, and transport
11 food grown or produced in the State, for distribution to
12 recipients at no cost to the recipients.

13 (d) For the purposes of this section:

14 "Food bank" has the same meaning as in title 7 United
15 States Code section 7501(5).

16 "Fresh locally grown or produced food" means fruits,
17 vegetables, nuts, coffee, eggs, poultry and poultry products,
18 livestock products, milk and milk products, aquacultural and
19 maricultural products, and horticultural products that are one
20 hundred per cent grown, raised, and harvested in Hawaii.



1 **§371K-B Hawaii food assistance program special fund.** (a)

2 There is established in the state treasury the Hawaii food
3 assistance program special fund, into which shall be deposited
4 the following:

5 (1) Appropriations made by the legislature to the special
6 fund;

7 (2) Gifts, donations, and grants from public agencies and
8 private persons; and

9 (3) Interest accrued from moneys in the special fund.

10 (b) Moneys in the Hawaii food assistance program special
11 fund shall be used for programs that provide hunger relief to
12 persons in need.

13 (c) Moneys deposited into the Hawaii food assistance
14 program special fund shall not lapse to the credit of the
15 general fund.

16 (d) Expenditures from the Hawaii food assistance program
17 special fund shall be authorized and administered by the office
18 of community services for the purposes of the Hawaii farm to
19 food bank program.

20 (e) The Hawaii food assistance program special fund shall
21 not be subject to section 36-27, 36-30, or 37-53.



1 (f) All procurements executed pursuant to this part shall
2 be exempt from the requirements of chapters 103D and 103F;
3 provided that the exemption shall not apply to goods, services,
4 or construction projects that directly benefit the office of
5 community services, including office computers, supplies,
6 furniture, flooring, consulting services, and any other items
7 that fill administrative or operational needs."

8 SECTION 3. Section 36-27, Hawaii Revised Statutes, is
9 amended by amending subsection (a) to read as follows:

10 "(a) Except as provided in this section, and
11 notwithstanding any other law to the contrary, from time to
12 time, the director of finance, for the purpose of defraying the
13 prorated estimate of central service expenses of government in
14 relation to all special funds, except the:

13 shall deduct five per cent of all receipts of all other special
14 funds, which deduction shall be transferred to the general fund
15 of the State and become general realizations of the State. All
16 officers of the State and other persons having power to allocate
17 or disburse any special funds shall cooperate with the director
18 in effecting these transfers. To determine the proper revenue
19 base upon which the central service assessment is to be
20 calculated, the director shall adopt rules pursuant to
21 chapter 91 for the purpose of suspending or limiting the



1 application of the central service assessment of any fund. No
2 later than twenty days prior to the convening of each regular
3 session of the legislature, the director shall report all
4 central service assessments made during the preceding fiscal
5 year."

6 SECTION 4. Section 36-30, Hawaii Revised Statutes, is
7 amended by amending subsection (a) to read as follows:

8 "(a) Each special fund, except the:

17 shall be responsible for its pro rata share of the
 18 administrative expenses incurred by the department responsible
 19 for the operations supported by the special fund concerned."

20 SECTION 5. There is appropriated out of the general
 21 revenues of the State of Hawaii the sum of \$ or so



1 much thereof as may be necessary for fiscal year 2023-2024 to be
2 deposited into the Hawaii food assistance program special fund.

3 SECTION 6. There is appropriated out of the Hawaii food
4 assistance program special fund the sum of \$ or so
5 much thereof as may be necessary for fiscal year 2023-2024, for
6 uses consistent with the purposes of the Hawaii food assistance
7 program special fund.

8 The sum appropriated shall be expended by the office of
9 community services within the department of labor and industrial
10 relations; provided that the office of community services may
11 retain ten per cent of the appropriation for its administrative
12 costs in entering into and overseeing contracts pursuant to
13 section 371K-A, Hawaii Revised Statutes.

14 SECTION 7. In codifying the new sections added by section
15 2 of this Act, the revisor of statutes shall substitute
16 appropriate section numbers for the letters used in designating
17 the new sections in this Act.

18 SECTION 8. Statutory material to be repealed is bracketed
19 and stricken. New statutory material is underscored.

20 SECTION 9. This Act shall take effect on June 30, 3000.
