# A BILL FOR AN ACT

RELATING TO MEDICAL CANNABIS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that restricting the
 interisland transportation of cannabis by qualifying patients
 for their personal medical use is contrary to the intent of
 state laws that authorize qualifying patients to use medical
 cannabis.

6 Accordingly, the purpose of this Act is to protect the 7 rights of qualifying patients to use medical cannabis by: 8 (1)Specifically authorizing the interisland 9 transportation of cannabis for personal medical use; 10 provided that no individual or entity shall be 11 required to violate federal law; and 12 Requiring the department of transportation to adopt (2) 13 rules for the interisland transport of controlled 14 substances within the State. 15 SECTION 2. Section 26-19, Hawaii Revised Statutes, is 16 amended to read as follows:

1 "§26-19 Department of transportation. The department of 2 transportation shall be headed by a single executive to be known 3 as the director of transportation. The department shall 4 establish, maintain, and operate transportation facilities of 5 the State, including highways, airports, harbors, and such other 6 transportation facilities and activities as may be authorized by 7 law.

8 The department shall plan, develop, promote, and coordinate 9 various transportation systems management programs that shall 10 include, but not be limited to, alternate work and school hours 11 programs, bicycling programs, and ridesharing programs.

12 The department shall develop and promote ridesharing 13 programs which shall include but not be limited to, carpool and 14 vanpool programs, and may assist organizations interested in 15 promoting similar programs, arrange for contracts with private 16 organizations to manage and operate these programs, and assist 17 in the formulation of ridesharing arrangements. Ridesharing 18 programs include informal arrangements in which two or more 19 persons ride together in a motor vehicle.

20 The functions and authority heretofore exercised by the 21 department of public works with respect to highways are

transferred to the department of transportation established by
 this chapter.

On July 1, 1961, the Hawaii aeronautics commission, the
board of harbor commissioners and the highway commission shall
be abolished and their remaining functions, duties, and powers
shall be transferred to the department of transportation.

The department shall adopt rules pursuant to chapter 91 for
8 the interisland transport of controlled substances within the

9 jurisdictional limits of the State, which extend twelve nautical

10 miles from the perimeter of each island and connect Oahu, Maui,

11 Molokai, Lanai, and Kahoolawe."

12 SECTION 3. Section 329-122, Hawaii Revised Statutes, is 13 amended by amending subsection (f) to read as follows:

14 "(f) For the purposes of this section, "transport" means 15 the transportation of cannabis, usable cannabis, or any 16 manufactured cannabis product between:

17 (1) A qualifying patient and the qualifying patient's18 primary caregiver;

19 (2) A qualifying out-of-state patient under eighteen years
20 of age and the caregiver of a qualifying out-of-state
21 patient;
