A BILL FOR AN ACT

RELATING TO FARM DWELLINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the emergence of 2 farm dwellings on agricultural park lots has contributed to 3 community complaints regarding dust, noise pollution, and other nuisances arising from the residential use of farm dwellings. 4 5 Concerns raised about residential activity on Maui agricultural 6 park lots, in particular, continue to place burdens on existing 7 farmers and ranchers. 8 The purpose of this Act is to prohibit: 9 Any person from residing, living, dwelling, or (1) 10 sleeping on any agricultural park lot unless within a farm dwelling that is permitted by the board of 11 agriculture after it conducts a thorough review of the 12 13 proposed use; and 14 (2) The construction of new farm dwellings on any

15 agricultural park lot.

1	SECTION 2. Chapter 166, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§166-</u> Farm dwellings; prohibited. (a) No person shall
5	reside, live, dwell, or sleep on any agricultural park lot,
6	except within a farm dwelling permitted by the board after a
7	thorough and comprehensive review that includes input from
8	adjacent landowners and lessees; provided that the board's
9	review shall include an evaluation of whether there are
10	appropriate buffer zones in place to address dust, noise
11	pollution, and other nuisances that may arise from the proposed
12	use of the farm dwelling.
13	(b) Beginning January 1, 2024, no new farm dwelling shall
14	be constructed on any agricultural park lot."
15	SECTION 3. During fiscal year 2023-2024, the department of
16	agriculture may inspect each agricultural park lot for
17	unpermitted farm dwellings. If an unpermitted farm dwelling is
18	found, the information shall be referred to the board of
19	agriculture.
20	SECTION 4. New statutory material is underscored.
