1	WHEREAS, career and technical education programs play an
2	important role in Hawaii's economy by providing critical
3	training to the State's future labor force; and
4	
5	WHEREAS, students participating in career and technical
6	education programs learn vital skills they need to attain
7	high-skill, high-wage careers in high-demand occupational
8	fields; and
9	
10	WHEREAS, the Department of Education offers its students up
11	to thirteen broad continuing and technical education pathways,
12	including culture, arts, media, and entertainment; business
13	management, finance, and marketing; health services; information
14	technology and digital transformation; building and
15	construction; advanced manufacturing; energy; architectural
16	design and engineering technology; transportation services;
17	agriculture, food, and natural resources; education;
18	hospitality, tourism, and recreation; and law and public safety;

21	WHEREAS, the University of Hawaii also offers a wide array
22	of continuing and technical education pathways for community
23	college students; and
24	
25	WHEREAS, although both the Department of Education and
26	University of Hawaii offer valuable programs, there is a lack of
27	clear coordination between the two educational systems; and

WHEREAS, ideally, a Department of Education student 1 participating in a career and technical education academy should 2 be able to seamlessly transition into: 3 4 A University of Hawaii community college career and (1) 5 technical education program following graduation from 6 high school; and 7 8 A career following completion of the community college 9 (2) program; and 10 11 12 WHEREAS, the Department of Education and University of Hawaii System should coordinate more closely to allow for these 13 seamless transitions: and 14 15 WHEREAS, Hawaii P-20, whose mission is to strengthen the 16 17 education pipeline from early childhood through postsecondary education and training, is well-positioned to help backwards-map 18 pathways from available careers through the various levels of 19 education and can help students determine when available jobs 20 may become available along the pathways; now, therefore, 21 22 BE IT RESOLVED by the Senate of the Thirty-second 23 Legislature of the State of Hawaii, Regular Session of 2024, the 24 House of Representatives concurring, that the Department of 25 Education, University of Hawaii Community Colleges, and Hawaii 26 P-20 are urged to develop clear pathways for students in 27 Department of Education Career and Technical Education Academies 28 to seamlessly continue their education in career and technical 29 education programs at University of Hawaii Community Colleges; 30 and 31 32 BE IT FURTHER RESOLVED that Hawaii P-20 is urged to assist 33 with the backwards-mapping of pathways from available jobs 34 through various levels of education and to help students 35 determine points at which they become qualified for available 36 37 iobs; and 38 BE IT FURTHER RESOLVED that the Department of Education and 39 University of Hawaii are both urged to publish the pathways on 40 their respective websites; and 41 42
