Your Committee reviewed the personal history, resume, and statement submitted by Sean Connelly for service on the State Foundation on Culture and the Arts.

Your Committee received testimony in support of the nomination of Sean Connelly from the Department of Business, Economic Development, and Tourism and State Foundation on Culture and the Arts.

Upon review of the testimony, your Committee finds that Dr. Connelly's experience and knowledge qualify him for appointment to the State Foundation on Culture and the Arts as an at-large member. Your Committee notes that Dr. Connelly has been involved in the arts for twenty-five years and was, most recently, an Adjunct Assistant Professor at Columbia University Graduate School of Architecture, Planning, and Preservation. In addition to a variety of teaching appointments and academic publications, Dr. Connelly is an accomplished artist whose work encompasses a variety of media including architecture, sculpture, film, and design. His works have been displayed at prestigious institutions
