Your Committee reviewed the personal history, resume, and statement submitted by Jesse Cooke for service on the Board of Directors of the Agribusiness Development Corporation.

Upon review of the testimony, your Committee finds that Mr. Cooke's professional experience, background, and desire to serve his community qualify him for consideration for appointment and reappointment to the Board of Directors of the Agribusiness Development Corporation as a member representing the City and County of Honolulu. Your Committee notes that Mr. Cooke has been a financial analyst for over twenty years and has an extensive background in investments, financial modeling, business lending, fundraising, research, and project development. Mr. Cooke has been serving as Vice President of Investments & Analytics for Ulupono Initiative since 2014, where he develops strategic initiatives to support projects and organizations that work to increase local food production. Your Committee finds that Mr. Cooke's involvement in Hawaii's agricultural industry, experience in the local food sector, and knowledge of financial matters and grants will aid in the decision-making process for the Board of Directors of the Agribusiness Development Corporation. Your Committee further finds that Mr. Cooke has been serving as an interim member of the Board of Directors of the Agribusiness Development Corporation and his knowledge and finance experience will continue to enhance the effectiveness of the Board. Your Committee therefore recommends that Jesse Cooke be appointed and reappointed to the Board of Directors of the Agribusiness Development Corporation based on his background, knowledge, and desire to contribute to the community.

As affirmed by the record of votes of the members of your Committee on Energy, Economic Development, and Tourism that is attached to this report, your Committee, after full consideration of the background, experience, and qualifications of the nominee, has found the nominee to be qualified for the position to which nominated and recommends that the Senate advise and consent to the nominations.
