Your Committee on Economic Development, to which was referred H.B. No. 1426, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO VALUE-ADDED PRODUCTS,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Establish a food and product innovation network with the Agribusiness Development Corporation; and
- (2) Appropriate funds for food and product innovation facilities on the islands of Molokai, Oahu, and Hawaii as part of the food and product innovation network.

Your Committee received testimony in support of this measure from the Department of Agriculture, University of Hawai'i Community Colleges, Agribusiness Development Corporation, Ulupono Initiative, Hawai'i Farm Bureau, and Hawaii Food Industry Association.

Your Committee finds that the establishment of a statewide network of open-access food and value-added product development facilities is critical to meeting the State's agricultural and economic diversification goals. Your Committee further finds that this network will allow businesses in the State to capitalize
