Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2458, H.D. 1, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF LAW ENFORCEMENT,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- Require the Director of Law Enforcement to investigate alleged violations of the law when directed to do so by the Governor or when the Director determines that an investigation would be in the public interest; and
- (2) Authorize the Director of Law Enforcement to issue subpoenas as part of the investigative powers of the Department of Law Enforcement.
