Your Committee on Housing, to which was referred H.B. No. 2787 entitled:

"A BILL FOR AN ACT RELATING TO THE INDIVIDUAL HOUSING ACCOUNT PROGRAM,"

begs leave to report as follows:

The purpose of this measure is to increase the maximum amount of deductible contributions for individual housing accounts.

Your Committee received testimony in support of this measure from the Grassroot Institute of Hawaii; Maui Chamber of Commerce; and eight individuals. Your Committee received testimony in opposition to this measure from one individual. Your Committee received comments on this measure from the Department of Taxation.

Your Committee finds that as the cost of housing increases, the State must continue to assist residents in finding methods of increasing options for homeownership. Saving for a down payment on a home loan continues to be a barrier for many Hawaii residents, as there are limited numbers of programs available to assist in this endeavor. This measure increases the contribution levels and maximum account levels individuals or married couples can contribute to their individual housing accounts under the State's Individual Housing Account Program to better reflect

current housing prices and further encourage prospective firsttime homeowners to save for a down payment and closing costs.

Your Committee has amended this measure by:

2024-1431 HB2787 HD1 HSCR HMSO

- Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Housing that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 2787, as amended herein, and recommends that it pass Second Reading in the form attached hereto as H.B. No. 2787, H.D. 1, and be referred to your Committee on Finance.
