"A BILL FOR AN ACT RELATING TO LAND USE,"

begs leave to report as follows:

The purpose of this measure is to:

- Require and appropriate funds for the Department of Land and Natural Resources to prepare plans and a program to facilitate voluntary relocation of residential development away from areas at risk of sea level rise;
- (2) Establish the Sea Level Rise Relocation Special Fund; and
- (3) Allow the exchange of public land for private land for the transfer of development rights or land exchanges to relocate private development away from high-risk areas, so long as the public interest is served.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources; Office of Planning and Sustainable Development; Surfrider Foundation, Hawai'i Region; and one individual. Your Committee received comments on
