The purpose of this measure is to appropriate funds to the Department of Land and Natural Resources to address the impacts of climate change in the State.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources, Hawai'i Emergency Management Agency, University of Hawai'i Sea Grant College Program and Climate Resilience Collaborative, Kauai Climate Action Coalition, Hawai'i Reef Ocean Coalition, Climate Protectors Hawai'i, The Nature Conservancy, and seven individuals. Your Committee received testimony in opposition to this measure from one individual. Your Committee received comments on this measure from one individual.

Your Committee finds that climate change is the overarching challenge for the State. Your Committee further finds that this measure provides resources to the Department of Land and Natural Resources to protect, manage, and restore natural resources, including native forests, native plants and animals, aquatic resources, coastal lands, and freshwater resources.
