"A BILL FOR AN ACT RELATING TO KALAUPAPA,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Require the Department of Health to include in its annual report regarding Kalaupapa Settlement:
  - (A) Details and updated information, as available, regarding the permanent transfer to other qualified governmental or nongovernmental entities of the powers and duties of state agencies over Kalaupapa Settlement; and
  - (B) Community engagement efforts with community stakeholders; and
- (2) Require the Governor to issue a proclamation to affirm the date of completion of the transfer of the Department of Health's powers and duties over Kalaupapa Settlement after they have been permanently transferred to other

qualified governmental agencies or nongovernmental organizations.
