The purpose and intent of this measure is to add the Chairperson of the Board of Trustees of the Office of Hawaiian Affairs to the Board of Agriculture.

Your Committees received testimony in support of this measure from the Office of Hawaiian Affairs and two individuals.

Your Committees received comments on this measure from the Department of Agriculture.

Your Committees find that the Office of Hawaiian Affairs is the principle agency of the State responsible for the performance, development, and coordination of programs and activities for the betterment of conditions of Native Hawaiians. Your Committees recognize that the Office of Hawaiian Affairs not only manages a substantial and every-increasing portfolio of agriculturally-zoned legacy lands, but also has dedicated a significant amount of funds to support Native Hawaiian farmers over the last decade. This measure recognizes the role of Native Hawaiian farmers and the value that customary Native Hawaiian agriculture and aquaculture practice bring to the State as it works to reach its food security

and sustainability goals by ensuring that Native Hawaiian interests are represented on the Board of Agriculture.
