"A BILL FOR AN ACT RELATING TO THE HAWAII INVASIVE SPECIES COUNCIL,"

The purpose and intent of this measure is to require the Hawaii Invasive Species Council to prioritize the protection of exceptional trees.

Your Committees received testimony in support of this measure from the Hawai'i Farm Bureau and one individual.

Your Committees received comments on this measure from the Hawaii Invasive Species Council.

Your Committees find that invasive species have become one of the most devastating problems impacting the State's environment and economy. Your Committees further find that the State has a duty to enhance, whenever and wherever possible, the natural environment of the State. This measure will further safeguard trees and stands or groves of trees with historic or cultural value from destruction. Your Committees have amended this measure by clarifying that the Hawaii Invasive Species Council shall prioritize the protection of exceptional trees from invasive species.
