Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2819, S.D. 1, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO TRAFFIC SAFETY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to require vehicles traveling ten miles per hour or more below the posted speed limit on a twolane highway, behind which five vehicles are formed in a line, to pull over where possible to let the trailing vehicles proceed when passing is safe.

Your Committee on Conference finds that traffic safety and congestion has been a key frustration for residents in the State. Your Committee on Conference believes that this measure will prevent collisions, improve operational efficiency, and minimize road rage statewide by requiring slow-moving vehicles to safely pull over to allow vehicles to pass safely.


