Your Committee on Judiciary & Hawaiian Affairs, to which was referred S.B. No. 2819, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TRAFFIC SAFETY,"

begs leave to report as follows:

The purpose of this measure is to require vehicles traveling ten miles per hour or more below the posted speed limit on a twolane highway, behind which five vehicles are formed in a line, to pull over where possible to let the trailing vehicles proceed when passing is unsafe.

Your Committee received testimony in support of this measure from the Department of Transportation. Your Committee received testimony in opposition to this measure from one individual.

Your Committee finds that this measure would improve the flow of traffic on certain roads where overtaking or passing slow-moving vehicles is not possible.

Your Committee has amended this measure by:

(1) Clarifying that vehicles traveling ten miles per hour or more below the posted speed limit on a two-lane highway shall pull over where possible to let the trailing

vehicles proceed when overtaking or passing is unsafe unless doing so would result in an unsafe situation; and

(2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Judiciary & Hawaiian Affairs that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2819, S.D. 1, H.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as S.B. No. 2819, S.D. 1, H.D. 2.
