Sirs:

Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 3070, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM FUNDING PERIOD,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to gradually reduce the Employees' Retirement System's maximum funding period to amortize the total unfunded accrued liability from thirty years to twenty years.

Your Committee on Conference finds that due to the Employees' Retirement System's (System) long-term investment performance, the funding period in which the System is expected to be fully funded has steadily decreased from the forecasted thirty years in fiscal year 2015-2016 to twenty-four years in fiscal year 2021-2022. Therefore, this measure will reduce the maximum projected funding period to amortize the total unfunded accrued liability of the

System from thirty years to twenty years, which would lower future costs, align the System with new Actuarial Standards of Practice, and allow the State to receive favorable ratings from bond rating agencies.
