Your Committee on Transportation and Culture and the Arts, to which was referred S.R. No. 155 entitled:

"SENATE RESOLUTION URGING TURO, INC., TO IMMEDIATELY CEASE AND DESIST LISTING ANY STATE AIRPORT PARKING LOT AS A VEHICLE PICK-UP SITE ON TURO'S DIGITAL PLATFORM,"

begs leave to report as follows:

The purpose and intent of this measure is to urge Turo, Inc., to immediately cease and desist listing any state airport parking lot as a vehicle pick-up site on Turo's digital platform.

Your Committee received testimony in support of this measure from Airlines Committee of Hawaii, Fair Wind Cruises, and one individual.

Your Committee received comments on this measure from Turo, Inc.

Your Committee finds that the proliferation of online carsharing platforms, including Turo, Inc., has exacerbated the scarcity of available parking spaces at State airports. Your Committee further finds that there are existing statutes and administrative rules aimed at regulating commercial activities at airports, including peer-to-peer car sharing. Your Committee concludes that it is imperative to regulate platforms like Turo, Inc., in order to address the challenges posed by the insufficient number of parking stalls at airports in the State.
