HB 1899 (HSCR733-24) Status & Testimony	RELATING TO STATE SNAILS. Designates certain snail species as official state snails.	TCA/AEN
HB 2650, HD2 (HSCR976-24) Status & Testimony	RELATING TO INVASIVE SPECIES. Appropriates funds to the Department of Transportation for the coordinated removal of albizia and other invasive trees. Requires matching funds from public utilities. Effective 7/1/3000. (HD2)	TCA/AEN, WAM/CPN
HB 2758, HD2 (HSCR701-24) Status & Testimony	RELATING TO AGRICULTURE. Facilitates the control and eradication of invasive species and pests. Establishes a plant nursery licensing program. Requires the Board of Agriculture to designate certain species as pests for control or eradication. Imposes certain limits on imports and transportation. Updates the method by which the Department's noxious weed list is updated. Effective 7/1/3000. (HD2)	AEN/TCA, JDC/WAM
