2017 Bill Introduction Highlights

Rep. Aquino has introduced over 30 bills this year relating to transportation, state facility needs in Waipahu and other community needs. Here are some bills to look out for this session:

HB724– Increases the fines for violations of operating a vehicle while under the influence of an intoxicant

HB731– Appropriates funds for capital improvement projects for the benefit of the 38th Representative District.

HB902– Appropriates general funds for 6.0 FTE positions for the UH Pamantasan Council to promote access and diversity, including for programs and policies related to Philippine courses and Filipino students.

HB653– Appropriates funds as a grant-inaid to the Honolulu Prosecuting Attorney to maintain and expand the weed and seed strategy, which is a collaborative effort to reclaim, restore, and rebuild communities.

HB1260– Requires county and municipal planning organizations to incorporate transportation mode share targets into county and municipal plans.

Lanakila Baptist Church & Schools Turns 50!



Lanakila Baptist Church

Lanakila Baptist Church will be celebrating its 50th anniversary! The first service was held on Wednesday, February 22, 1967 in the home of Robert Knutson on Kahuanui Street. The first Sunday service, held on February 26, took place in a portable classroom at Waipahu Intermediate School.

In 1968, Lanakila Baptist Church purchased an acre of land from the old Amfac Inc./Oahu Sugar Company on Waipahu Street. Construction was finished in 1971. Lanakila Baptist Church our Ewa Villages campus in 1979 and moved our Intermediate and High School to that facility on Renton Road.

Lanakila supports over 50 mission projects around the world. Since the mission program began in 1967, the church was given over \$3 million to start churches, Christian schools, medical clinics, food banks and post-secondary Christian colleges in more than 100 countries of the world. In 2001, the church began its Fall Food-Drive and have collected over 160,000 pounds of food for donation.

August Ahrens VEX-IQ Robotics Team 10932B won "Overall Team Excellence Award" at their tournament in December. The state competition will be held in February.



Helpful Information

LAWYER REFERRAL AND INFORMATION SERVICE (LRIS)

Members of the public who are seeking the services of an attorney may call, fax or email the Hawaii State Bar Association (HSBA) LRIS staff. After assessing the issues or concerns of the individual, the individual is given the names and contact information of two attorneys.

The attorneys on the LRIS panel are screened prior to being placed on the panel for liability insurance, past or pending disciplinary action, and subject matter specialization.

Note: Individuals who seek services may qualify for free legal services due to limited income. If the individual does qualify, the Lawyer Referral staff will direct the individual to the appropriate legal service provider.

LEGAL LINE

Attorneys are available via telephone to provide legal information on Wednesday evenings from 6 p.m. to 7 p.m. The volunteer licensed pro bono attorneys will try to assess the issues and refer the callers to the appropriate HSBA staff, legal service provider or government agency which may be contacted for assistance. ACCESS TO JUSTICE ROOMS (Honolulu District Court and Kapolei Family Court)

Access to Justice Rooms, which provide legal advice, have been established at the Honolulu District Court and the Kapolei Family Court Complex. Trained volunteer pro bono attorneys provide legal advice in limited areas to self-represented litigants.
