Dear Friends:

Happy 2012! I hope that you and your families enjoyed a safe, happy holiday season, and that the new year is off to a wonderful start. On a personal note, this year has started very memorably for me, as I celebrated my wedding to Vince

Todd on January 15, 2012. Vince is a UH-West Oahu professor, and you may have met him over the last few years as he accompanied me to many community events. We consider ourselves very fortunate to be embarking on the next chapter of our lives together.

Here at the legislature, the 2012 session began on January 18. We are excited this year to continue working on a number of important issues we addressed last year, as well as facing some new challenges and opportunities. As you may remember, we have dealt with significant deficits of \$2.1 billion, \$1.2 billion and \$1.3 billion over the past three legislative sessions. Fortunately, as the economy has continued to slowly improve, we are not anticipating another sizable deficit and may in fact see a slight surplus. (The Council on Revenues will meet again in March to give us a more detailed picture of the state's financial situation).

Even if there is a surplus, however, we still have some challenging work ahead of us as we work to stabilize our state's economy, promote growth and ensure that government's core functions of health and welfare, public safety and education are adequately fulfilled following several years of

difficult cuts. As a member of the Finance Committee, my top priority will be reinforcing our state's economy by introducing bills to create jobs, to minimize government regulations impeding small business, and to ensure no new taxes from state government on businesses and residents. I will also be introducing a number of bills on a variety of topics,

including strengthening penalties for uninsured and unregistered drivers, bringing creative industry jobs to Hawaii and streamlining procurement procedures. As we begin this legislative session, I also hope that you, my constituents, will take time to share your thoughts and priorities on our state's budget and other issues by completing the survey on page two.

Funding Released for Area Projects

New state funding has been released for a number of projects in and around our district. The Department of Civil Defense has assigned \$2.2 million for improvement of Army Guard and National Guard Facilities statewide, including Buildings 46 and 1784 at Kalaeloa. In addition, the Hawai'i Community Development Authority will be undertaking improvements on Coral Sea Rd., Roosevelt Ave, Philippine Sea St., Eisenhower Rd, and Tripoli St, including the installation of signs, pavement markings, minor grading work, and lane realignment.
