PARTICIPATE IN YOUR DEMOCRACY

In 1990, the Hawaii State Legislature established the Public Access Room (PAR) to provide the public with necessary resources for participation in the legislative process. It is the first stop for Hawaii's citizens when working with the Legislature— whether from home, office or at the Capitol. They are deeply nonpartisan and maintain their objectivity in order to serve the needs of those who use their facilities and services. There is never a fee for services.

Beginning on January 5, 2016, PAR will be holding "We the Powerful!" workshops every Tuesday from 12:00 p.m. to 1:30 pm. The 90-minute workshop ends with time for focus and collaboration on matters of interest to the participants. The flexible nature of the workshop provides a useful start for newcomers as well as information and inspiration for veterans of the legislative process.

Topics covered by the workshop include:

- Tips and techniques on effective lobbying, testimony and communication with Senators and Representatives.
- Understanding the legislative process deadlines and power dynamics.
- Easy to use tools available on the Legislature's website.
- Helpful handouts, guides and resources.

In order for a bill to become law it must be introduced by a legislator

AND

COMMITTEE HEARINGS

Successfully pass through all the committees the House and Senate refer it to



FLOOR VOTES

AND

⇒ Successfully pass three readings (votes) in both the House and Senate chambers (where all the members convene)



AND

⇒ Have both the House and Senate agree on its exact wording



AND



⇒ Be signed or allowed to become law by the Governor, or have the House and Senate successfully override the Governor's veto (if vetoed, need 2/3 of each chamber to vote to override in order for bill to become law)

⇒ It must do all of this, while adhering to strict legislative deadlines!
