The Senate Ways and Means Committee and House Finance Committee announced that State Grants-in-Aid applications are being accepted now through Friday, January 20, 2017, for the 2017 Regular Session. Qualified non-profits and other organizations who meet the requirements under Hawaii Revised Statute Section 42F-103, may apply.

Previously, grants were appropriated for various public purposes that were recognized as complementary to state government functions, including health, education, workforce development, social services, and cultural and historical activities. Last year alone, nearly \$37 million was awarded to organizations across the state.

UH-WEST OAHU ALLIED HEALTH/ADMINISTRATION BUILDING GROUNDBREAKING

On November 28, 2016, I had the honor and privilege to join Governor Ige and other dignitaries at the ground breaking for the University of Hawaii – West Oahu campus' Allied Health and Administration building. I worked tirelessly at the legislature to help secure the \$36 million needed to build this two-story structure. Anticipated to be completed in 2018, this addition is another step in expanding our West Oahu campus.

This 43,000 square foot building will include administrative and faculty offices, classroom and lab spaces, and will house programs such as the allied health, community health, health and information management, long term care, and biology programs. The Allied Health programs are continually being developed and updated with the community and industry in mind. By anticipating workforce needs to assist with Hawaii's aging population, these programs will provide career opportunities for West Oahu students.
