GOVERNOR CALLS SPECIAL SESSION ON SAME-SEX MARRIAGE

As you know by now, the governor has called the Legislature back in for a special session regarding same -sex marriage. The special session will convene on Oct. 28, 2013. The Legislature must meet for a minimum of five days during a special session. No closing date has been set but House leadership hopes that special session will last no longer than five days.

The same-sex marriage bill that the governor has proposed must go through 3 readings in both chambers. After passage on first reading (which is a normal process for all bills that have been introduced at the legislature) the bill will be referred to the House Judiciary Committee, of which I am the vice chair. The Committee on Finance may also be assigned to hear the bill, either jointly with the Judiciary Committee or on its own. If the bill makes it past the House, it will be transmitted to the Senate where it will follow the same process. If the bill passes both chambers of the Legislature, it will be transmitted to the Governor for his signature.

I encourage all of you to participate in the legislative process, and to testify on the bill when it is scheduled for a public hearing. You may sign up to receive legislative hearing notices at capitol.hawaii.gov/login/register.aspx. The notice will provide specifics on when and where to provide testimony. In the meantime, you can also contact Governor Abercrombie at governor.abercrombie.@hawaii.gov, Representatives-reps@capitol.hawaii.gov, and Senators- sens@capitol.hawaii.gov to express your opinions on the upcoming special session, same-sex marriage or both.

NEW U.S. SOCIAL SECURITY ADMINISTRATION OPENS IN KAPOLEI

Residents and dignitaries gathered together to celebrate the grand opening of the U.S. Social Security Administration office on Wednesday, September 4th, 2013.

The opening of the social security facility completes the second phase of development for the Second City. The office will be open from 8:30 a.m. until 2:30 p.m. Monday through Friday and is closed on the weekends. The facility is located at 970 Manawai Street, next to the Kapolei Public Library.



SECTION OF OLD FARRINGTON HIGHWAY CLOSED FOR RAIL PROJECT WORK

Motorists who routinely use Old Farrington Highway should be advised that old Farrington Highway between Kualakai Parkway (North-South Road) and Old Fort Weaver Road Loop is closed 24/7 as part of utility relocation work related to the rail project. The Honolulu Authority for Rapid Transit (HART) has informed my office that Kiewett Infrastructure West is relocating a 30-inch water line along old Farrington Highway just west of the Kahi Mohala Behavioral Center.

Traffic in both directions of Old Farrington Highway will be detoured to either the H-1 freeway or other nearby roadways. Drivers travelling between East Kapolei and the Ewa/Waipahu region will still be able to access either side by using the Kapolei Parkway or Geiger Road on the south end of Kualakai Parkway, or the H-1 freeway on the north end.

Kiewett Infrastructure West is coordinating with TheBus in relocating bus stops along the affected area and in ensuring local employees and business-related traffic can continue to access the area. Motorists will still be able to access the Kahi Mohala facility during the detour.


CHILDREN & YOUTH DAY TO BE CELEBRATED ON OCT 6

E OLA PONO MA KAPOLEI COALITION COMMUNITY CLEAN UP

E Ola Pono Ma Kapolei, a Coalition for a Drug-Free Hawaii partner comprised of a broad spectrum of schools, businesses, churches, individuals, community organizations, parents, youth, and state and county government agencies, is sponsoring a "community work day" on Saturday, October 5, from 9:00 a.m. to 11:00 a.m. to clear debris, pull weeds, and re-plant native vegetation in seven Kapolei recreational and cultural areas.

Individuals and organizations with wheelbarrows, shovels, buckets, work gloves, and digging tools are especially needed to clear debris, brush and weeds and to re-plant native vegetation. Parks to be cleaned are Kamokila Park, Kapolei Community Park, Kapolei Regional Park, Hula Mound, Archery Range, Kalaeloa Trail and Cultural Park, and Barbers Point Beach Park. Kapolei Middle School and Kapolei High School will also be cleaned and painted.

Volunteers are asked to arrive at Kapolei High School by 8:30 a.m. Following the clean-up, at 11:30 a.m., volunteers will be served lunch in the Kapolei High School cafeteria.
