District 2 Improvement Projects

1. Wailoa Small Boat Harbor Entrance

• Funding for the US Army Corps of Engineers to study and design the mitigation to the sand deposits at the entrance of the Wailoa Small Boat Harbor in Hilo, HI.

2. Mt. View Post Office

Funding for the US Postal Service to plan and design improvements to the Mt. View Post Office in Mt. View, HI. Work to include but not limited to: expanding the capacity of the Post Office; close the entry to the Post Office from Hwy 11; provide a security fencing from Hwy 11 to insure postal customers will not park on the shoulder of Hwy 11 to access the Post Office; extend the Old Volcano Road to the mauka side of the Post Office parcel; acquisition of the parcel; improve the Post Office parcel to connect to the Old Volcano Road for entry/exit; and add parking for staff and postal customers on the Post Office parcel.

3. Puainako Street

Funding for the widening of Puainako Street in Hilo, HI. Provide matching funds to the Hawaii State Department of Transportation Highways Division for the widening of Puainako Street from the intersection of Puainako Street and Iwalani/Kawili Streets to Hwy 11. The widening of Puainako Street will address the early morning and afternoon traffic congestion and safety of students on Puainako Street because of the Waiakea Elementary and Waiakea Middle Schools.
