### **LEGISLATIVE ISSUES**

Here are some of the issues I am keeping an eye on:

#### **Elder Abuse**

- I voted in support of HB 2192 which makes it harder to take advantage of our elders in financial matters.
- I also supported HB 2098 which allows someone who was taken advantage of financially the opportunity to sue for damages.

#### **Cyber Crime**

- HB 1776 on companies providing information to law enforcement in emergencies has passed the house judicial committee with amendments.
- HB 1709 which makes it a felony to impersonate another person and commit aggravated harassment against someone also passed the house judicial committee with amendments.

## SUSTAINABLE FOOD SUPPLY

An upcoming *Time With Kymberly Pine* show on Olelo features Chef Ed Kenney of Town and Downtown restaurants. His motto is to buy 'local first, organic when possible, with aloha always.' He talked about how he buys directly from local farmers to create the menu at his restaurants. HB 2703 is about food sustainability by the year 2020. If we can increase our local produce from farmers by 10 percent, that will create more than 2,000 jobs.

# **LEGISLATIVE PACKAGE FOR 2012**



My colleagues and I created a legislative package for 2012 to solve some of the challenges facing our state. We have a fourpart recovery program to stabilize jobs, lower the cost of living, protect our community, and improve government transparency and accountability.

Many people in our community have said that jobs and the economy are on the forefront of their minds. Some residents may be counting on their last dollar or coin - to get the things that they need most. To make it easier on businesses to create jobs, we support a bill that gives business owners an income tax credit when they hire people who are on unemployment. The tax credit would be equal to the amount of unemployment insurance taxes paid. To get the credit, the job needs to be a full-time permanent position. Another bill would delay the scheduled unemployment tax increase. Businesses presently pay about \$667 per employee.

Some business leaders say the scheduled increase would add about \$180 to \$650 per employee. If the increase goes up as scheduled, it may make it harder for businesses to hire people. In addition, I support a bill that creates a property-assessed clean energy (PACE) program in Hawaii. PACE allows home owners and business owners to obtain low-interest loans that cover the upfront costs to install renewable energy systems and increase energy efficiency.

The second part of our plan is to make government more transparent, we have several bills that we proposed. One bill requires an audit of all special funds to be done on a regular basis which assists in shedding light on how your tax dollars are being used. Also the Legislature will look at a bill to require all legislation to include any costs involved. This would let lawmakers and the public know how much money a bill would cost or generate in before it passes. We also want more transparency on nominees for any appointments including judicial and legislative positions. This empowers the people to give their input before the position confirmation is made when the names of the nominees are released.

In other areas of transparency, we are asking that the balance sheets for the state departments be made available online for the public to see so they know where their money is going to.

Our third part focuses on lowering the cost of living. To do that we are proposing bills that require a two-thirds vote by the legislature on any tax or fee increase. Another way to lower the cost of living is to support a bill that allows other types of biofuels so we will be less dependent on the costly fuel importation.

The fourth part protects our community. We want stronger computer fraud laws since nearly everyone is online. My colleagues and I are pressing for higher penalties for people who illegally access computer systems. We are also proposing a bill that allows Hawaii courts in criminal cases to issue a warrant, subpoena, or order the reproduction of records outside Hawaii.
