## **Good Policy Comes from Listening to Constituents**

No matter big or small, I strongly believe good policy is shaped by voices that reflect the realities of life. Most recently on the issue of minimum wage, I spoke with Kaimuki business owners and found that while Hawaii's economy has recovered, many local, small businesses are struggling with supply chain delays, high oil prices, and rising medical premiums.

Through candid and informed conversations, I can better represent you and our community in the Capitol. To facilitate these conversations, I will be organizing town halls throughout the district. # **Legislative Activity**

#### **Fighting Against Youth Vaping**



Rep. Sayama joined a coalition led by students to advocate for banning flavored vaping products that market addictive nicotine products to children. While being just as addictive as cigarettes, e-cigarettes incorporate sweet and fruity flavors to attract younger users. #### Light at the End of the Tunnel

Rep. Sayama speaking on the importance of his catalytic converter bill as it passes the House. A product of collaboration from the State Attorney General, the City Prosecuting Attorney, HPD, and myself, this bill calls for stricter penalties and greater oversight for the industry. While this bill stalled in the Senate last year, I'm optimistic this issue will be addressed in this legislative session.





#### **Supporting Retirement Savings**

On March 17th, Rep. Sayama's committee on Labor and Tourism heard and passed SB3289, which aims to increase access to employees who lack retirement plans by establishing the Hawaii Retirement Savings Program. By investing in this program and helping people off of social services, the State may save millions of dollars in the long run.

### **State COVID-19 Mandates Update**

Starting **March 26th, 2022** Hawaii will end two major COVID restrictions, **(1)** COVID-19 travel requirements for domestic travel—meaning travelers coming from other states or U.S. territories, won't have to provide proof of vaccination or a negative COVID test. And **(2)** Hawaii's indoor mask mandate: masking indoors will no longer be a government mandate. Private businesses may still require masks for customers and employees.

### **Renewal and Vision for Kaimuki's Future**

On March 18th, I toured the site of the future "Goodwill Building" in Kaimuki and was impressed with the Omidyar Group leading this project. From going door to door to answering questions at neighborhood board meetings, community was a clear priority in every step of their project. A block down the street, I spoke with Adoree Yu, who was cleaning up the interior of the Queen Theatre to show case the property. While there will always be anxiety around changes in our community, these projects bring new opportunities for businesses and our communities. Together, with engagement from the community we can build a new future that meets the needs of the present and honors past traditions.
